The application includes an oath of office, which must be sworn and notarized. In addition to the application form and fee, the applicant must have taken and passed the notary public examination. Examinations are regularly scheduled throughout the state. NYS Attorneys and court clerks of the Unified Court System are exempt from the examination.

### NYS Division of Licensing Services

The exam is multiple choice. Exam topics include: License law, general terms and information related to the duties and functions of a notary public, as outlined in the "Notary Public License Law" booklet available from the Division of Licensing Services. Applicants will be allowed 1 hour to complete the exam.

### Free Practice Exam Answers - Official NY State Notary ...

The laws of the State of New York do not require the use of seals by notaries public. If a seal is used, it should sufficiently identify the notary public, his authority and jurisdiction. It is the opinion of the Department of State that the only inscription required is the name of the notary and the words "Notary Public for the State of New York."
